Wedding Ceremonies at the Cathedral of Aghia Sophia

General

- Dates: Once a date is agreed, it will be provisionally entered into the church diary for 14 days.
- Deposit: A non-refundable deposit of £200 is required to confirm the booking (see Section 3: Payment Information). If not paid within 14 days, the booking will be cancelled automatically.
- **Cancellations:** If you decide not to proceed, please notify us as soon as possible so we may release the date for others.

Section 1: Legal Requirements & Paperwork

It is your responsibility to make the necessary legal arrangements before your wedding at the Cathedral.

1. Giving Notice

- You must make an appointment at your local Registry Office to give notice of your intention to marry or form a civil partnership.
- Both partners must give notice separately if living in different registration districts.
- Notice must be given at least 29 days before the ceremony and is valid for 12 months.
- Without giving notice, the marriage cannot take place.

2. Legalising Your Marriage

Option A – Registrar at the Cathedral

- Invite a Registrar from Westminster Council to attend the religious ceremony and legalise the marriage.
- The process takes an additional 5–10 minutes after the 40-minute religious service.
- Booking the Registrar is your responsibility: Westminster Council Registrar Information

Option B - Civil Ceremony Beforehand

- If you do not invite a Registrar, you must first have a civil ceremony at your local town hall.
- Proof of the civil marriage must be submitted well in advance.

For Couples from Outside the UK

- You must give notice together at a Registry Office, unless both hold one of the following:
 - o British or Irish citizenship
 - o Settled or pre-settled status under the EU Settlement Scheme
 - o A pending application made before 30 June 2021

3. Certificate of Non-Impediment

Orthodox participants must provide a **Certificate of Non-Impediment**:

- Valid for 6 months only.
- Cost: £20 per certificate (per person), payable to the Greek Orthodox Archdiocese of Thyateira and Great Britain.
- Documents required:
 - Baptism certificate
 - Passport
 - o Two witnesses with passports (not close family and not from your partner's family)

Certificates are obtained:

- From your baptismal parish (if baptised in the UK)
- From St Sophia (if baptised abroad and living in the UK for 3+ years)

4. Permission to Marry

- Once certificates are provided, our priest will apply for a Permission to Marry from the Archdiocese.
- Cost: **£60**, payable directly to the Archdiocese via bank transfer.

Section 2: Mixed Religious Weddings

• If one partner is Orthodox and the other belongs to another Christian denomination (e.g. Anglican, Catholic), a Baptism Certificate must be provided.

- Non-Orthodox Christians do not need a Certificate of Non-Impediment.
- The Orthodox Church does not perform marriages between Christians and non-Christians. If the non-Christian partner wishes to marry in the Church, they must first be baptised. Contact Fr Nephon Tsimalis at: archdiocesanprivateoffice@gmail.com

Section 3: Payment Information

- Wedding Ceremony Fee: £680 (one-hour slot)
- Exclusive Cathedral Booking: £2,500 (whole day, no other ceremonies)
- Deposit: £200 (non-refundable, required upon booking confirmation)
- Balance Payment: Due two weeks before the ceremony
 - o £480 (for one-hour slot)
 - £2,500 (for whole day booking)

Payment Methods:

- Bank transfer or cheque only (no cash)
- Additional donations may be made at your discretion

Choir, Cross, Chanter

A chanter will be provided at no extra cost. In addition, you can pick one of the following options:

- Choir with Cross: £760 (includes a £100 non-refundable deposit)
- Cross only: £100 (paid in cash to the Verger on the day)

Section 4: Ceremony Requirements

- Two crowns (conjoined)
- Gold bands
- Bottle of Koumandaria (sweet wine)
- Wine goblet (optional)

- Two large white bridal candles (max. 8cm optional)
- Tray with sugared almonds (*koufeta*) or rose petals

Best Man/Woman (Koumbari): Must be Orthodox. Non-Orthodox may serve only as witnesses.

No Weddings Permitted On:

- 13–26 December (Christmas)
- 5–6 January (Theophany)
- 29 June (Feast of Apostles Peter & Paul)
- 1–15 August (Dormition Fast)
- 29 August (Beheading of St John the Baptist)
- 14 September (Exaltation of the Holy Cross)
- During Lent: From Forgiveness Sunday until Easter Sunday
- Pentecost & Holy Spirit Monday
- Two Saturdays of the Souls (Psychosavvata)

Lent & Feast Dates (Examples):

- 2026: Lent 22 February to 13 April
- 2027: Lent 14 March to 2 May

Section 5: On the Day

- Please arrive on time. Late arrivals may result in waiting until other ceremonies are completed.
- A late fee will apply (for both Cathedral and choir).
- Strictly no confetti or rice inside or outside. Only a small amount of biodegradable rose petals is allowed outside. A £100 fine applies for non-compliance.

Section 6: Parking

- No on-site parking available.
- Parking meters are available on Moscow Road and nearby streets.
- Free parking after 1:30 pm on Saturdays and all day Sundays (on single yellow lines and payand-display meters).
